MESO is fortunate to be able to provide zero-interest loans to cities for energy conservation, and customer assistance programs.

If you are interested in applying for a one-year interest free loan from MESO, please complete the enclosed one-page application. The loan may be applied to any activity that may result in the reduction of electric energy use or in a customer conservation program. For example, we have made loans for voltage control equipment, new street lighting and for line upgrades.

The loan application will be reviewed by the MESO Board of Directors. The main criteria used to judge the loan application will be the level of probable energy savings per dollar of investment. Loans that are customer side energy program such as rebates or credits for new lighting, insulation, or equipment may be extended for two years at the option of the Board.

If your city wishes to receive a loan, please provide MESO Board a full explanation of the project to be done (drawings, diagrams, or maps may be useful). Include a budget for the project, note the estimated value of city personnel time and equipment to be used on the project, note any city funds that are to be used on the project in addition to loan funds. Finally, provide an estimation of projected kwh savings on an annual basis as a result of the project and an estimate of KW peak reduction that may result.

**LOAN AGREEMENT**

4. Should the approved loan project require funds in excess of the amount approved by this loan agreement, interest accrued on loan funds may be applied to the execution of the approved project. 5. The utility agrees to provide to MESO as may be required by MESO reports on the loan project's success in achieving energy conservation.
